TO DISCUSS/REVIEW:

Correspondence: Town Administrator Burbank was delivered a picture of a home at 103 Pennyroyal Lane that has added an outdoor staircase without a building permit. The location of the staircase suggests that it leads to an accessory apartment, which the homeowner would have had to seek approval from the Planning Board for. A letter will be sent to the homeowner letting them know that they will need to rectify the situation.

Other Discussion:

Town Administrator Burbank said that while at the NHMA Annual Conference, she learned about a company called Freedom Energy Logistics which offers a Community Choice Aggregation program that allows members to have better buying power for electricity and possibly achieve better rates. The Board may invite a representative from the company to present information.

Cable Consortium: Selectman Meth asked if the town had money to do a resident survey, as was recommended by Katherine Miller Esq., of Donahue, Tucker and Ciandella, with the intent of finding out how many residents would subscribe to cable if it were available to them. Selectman Meth is also waiting to hear back from Mountain Top Telecom regarding a proposal they are creating for town wide cable access.

Planning Board: Met on November 12th regarding a lot line adjustment.
