
Q2 Are you a full time Franconia resident?




Q3 Do you own or rent your home?




Q5 Do you have school aged children?

Q6 How important is maintaining Franconia's natural landscape?





- 1. is important but we need housing that locals can afford, and we need more year round residents instead of seasonal people. It doesn't really feel like a community. :(
- 2. Keeping the forested landcover, maintaining clean watersheds (and restoring those that need ecosystem repair, such as the Ham Branch and the downstream end of the Gale past Sugar Hill Bridge), and maintaining and improving the wildlife corridors is essential in this age of climate change. Too much has been sacrificed with the development habits of the past 20 years, and particularly the past 5 years. We are seeing more invasive plant species, and wildlife corridors are disrupted. People new to town (and some not new) need education on such things as maintaining riparian buffers and using native plantings.

Q7 How important is conserving scenic areas, natural resources, open space and scenic views?






QUESTION 8, COMMENTS: 9

Q9 How important is improving bicycle and pedestrian infrastructure?







Q11 How important is improving regulations on short term rentals such as Airbnb?







QUESTION 11, COMMENTS: 24

- 1. They are often loud. They are sometimes obnoxious. They have no investment in the community. And low priced homes and even apartment buildings are being lost to AirBnB sometimes even to local rich people who should know better or at least care.
- 2. Absolutely! It's out of control!
- 3. Is this why locals can't find any rentals? There are no rentals!
- 4. We should not be over-regulating short-term rentals if we want to drive more visitors to enjoy and support the area.
- 5. The rapid emergence of Air BnB is a big problem in Franconia (and surrounding towns) by its removing affordable apartments and homes from the rental or purchase market. It also removes places for young families with kids to live, which decreases the size of the school, and thus decreases some of the per-student federal/state funds for local education. Local Air BnB owners claim they upgrade the look of their buildings, but that doesn't mitigate the damage done to modest-middle income people who can't find an affordable place to buy. And, short-term rentals also need to pay the same commercial property taxes that motels and inns pay, rather than being able to pay residential home rates. Lastly, there needs to be accountability to neighbors. If we had a nuisance motel occupant, there are ways to contact and deal with owners. This is not the case with short-term rentals, except for those rare ones with the owner living on site. (This latter situation would mitigate some of the issues.)
- 6. Airbnb's bring tourist money to the area, so I support having them. They are a convenience for many people with children and/or pets.
- 7. weight limits/garbage trucks on scenic roads and dirt roads maintained by the town. Casella is using very large trucks on Ridge Road.
- 8. Not clear what is meant here but there clearly are lots of investors and multi-home owners running airbnb's in town particularly in the last 2 years. I view this *almost* as a commercial venture in town that consumes town resources and increases traffic and congestion. Franconia seems more suburban to me than it used to.
- 9. There are houses in town that are used for short-term rentals that list occupancy as much higher than their septic systems likely allow. Some of these are quite close to water sources. The prevalence of these rentals also create a public safety issue if there are emergencies, as one may not know who is inside or the renters may not be able to contact the owners quickly. These rentals also take up much needed and necessary housing supplies for long term residents.
- 10. This issue needs to be addressed before it spirals out of control. Zoning is necessary.
- 11. We need to figure out how to balance the number of rentals with the second homes and year round residences.

- 12. I see this as a problem for our community if it does not have some serious regulation. Outsiders being up property and renting to whomever, large numbers filling up small homes, putting stress on water usage, plumbing concerns excessive noise, and neighborhood disruption.
- 13. Not sure what the question is traffic control? Noise control?
- 14. We need to make it affordable for young families that aren't trust fund babies to live in the town. I've heard some ideas other towns are doing to address this issue and like the idea that if you don't live in the town there is an added tax or only residents can have Airbnbs. I also liked the idea of what Conway tried with Airbnbs not being residental in regards to zoning but sounds like they had to back away from that.
- 15. Wish there were less short term rentals and more locals in those homes!
- 16. I don't know what the current regulations are nor why we would need to improve them
- 17. I can't answer, I have no knowledge of the current regulations or the extent to which properties are being rented.
- 18. Existing rules and registration requirements are sufficient. Many area homeowners rely on short term rental income to cover expenses such as property taxes. Additional regulatory burden would NOT be an 'improvement' and, therefore, the phrasing of this question is misleading.
- 19. We do not do short term rentals but this is not that important. We have not had issues in our neighborhood with Airbnb disruptive rentals.
- 20. It is obvious that people living in this town can no longer find or afford houses to purchase and become or remain full-time residents. Interestingly, the Mount Washington Valley study of short term rentals determined that short term rental of housing does not cause a lack of employee housing (although that may be a result of the study being conducted by the short term rental owners.) Perhaps North Country Council or a similar organization could delve into this question to give Franconia a clear picture of the cause and effect of short term rentals of homes in this area.

- 22. With more and more short term rentals the available annual leased properties decreases making it difficult for those who work locally to live locally. The availability of housing for service workers is important to the community.





- 35. Town Hall, Abbie Greenleaf Library, Police/Fire/Ambulance all of these are important structures that should be maintained and upgraded as needed.





Q16 How important is increasing access to high-speed broadband?






