#### TRUSTEES OF TRUST FUNDS

## January 17, 2024

In attendance: Jan Cole, Karen Foss, Carol Walker & Mike Betley

The meeting commenced at 4:20 pm.

<u>Transactions for December 2023</u>: The Capital Reserve Fund (CRF) reported additions of \$4,575.00 for the Cemetery right to inter funds deposit and \$57,454.53 from Lafayette Rec income for a total of \$62,029.53. Subtractions totaled \$162,042.64 from withdrawals of \$810.00 for the Cemetery Maintenance fund for fence & stone repair, tree & brush removal, \$3,287.00 for the Town Building Maintenance fund for the Transfer Stations deposit on a heating system, \$4,072.64 for the Highway Department Truck tires & rims for the 2023 Western Star truck, \$3,284.10 for Town Buildings Vehicle for tires & rims for the 2023 one ton truck, \$50,451.78 for Lafayette Rec reimbursement of 2023 expenses, and \$96,896.36 for the Highway Department Truck final payment for the 2023 Western Star truck. There was a \$20.00 transaction fee and payment of the 4<sup>th</sup> quarter Three Bearings' fee of \$3,220.76.

The Common Trust Fund (CTF) reported transactions in December with subtractions of \$1,864.32 for a \$1,518.64 withdrawal for Perpetual Care mowing and Three Bearings' 4<sup>th</sup> quarter fee of \$345.68.

The Trustees reviewed the December 1-31, 2023 Three Bearings/Fidelity Common Capital Reserve Fund (CRF) report with a beginning balance of \$2,906,801.76 on 12/1/2023. After deposits totaling \$62,029.53 from the Cemetery for the right to inter and income from Lafayette Recreation events as detailed above, subtractions totaling \$162,022.64 for the CFT reimbursements to the Town (detailed above under "Transactions for December 2023") for the Western Star Truck purchase, Lafayette Recreation expenses, tires and rims for the 2023 one ton truck and the new Western Star Truck, the down payment for a heating system at the transfer station, cemetery maintenance and repair costs, Three Bearings' CRF quarterly advisory fee, and transaction costs, there was an increase of \$57,287.53 in the CRF investment value, resulting in an ending account value \$2,864,076.18 at 12/31/2023. For 2023, There has been an increase of \$211,690.73 in the CRF Investment value for the year ending 12/31/2023. Dividend income for December was \$9,645.07.

The Trustees reviewed the <u>December 1-31, 2023 Three Bearings/Fidelity Common Trust Fund</u> (CTF) report with a beginning balance of \$311,985.64 on 12/1/2023. After subtractions totaling \$1,864.32 (details are noted above in "Transactions for December" for perpetual care lot mowing and Three Bearings' CTF quarterly advisory fee, there was an increase of \$14,185.26 in value in the CTF resulting in an ending account value of \$324,306.58 at 12/31/2023. There has been an increase of \$24,348.58 in the CTF Investment value for the year ending 12/31/23. Dividend income for December was \$2,629.17.

<u>The MS-9's</u> for the periods from 1/01/2023 through 12/31/2023 and 12/01/2023 to 12/31/2023 were reviewed; as noted above in December Transactions, \$1,518.64 in income from Perpetual Care funds was withdrawn on mowing; principal withdrawals totaling \$100,969.00 from the Highway Department Truck CRF to purchase the 2023 Western Star truck, tires and rims; Cemetery Maintenance Fund

received a \$4,575.00 principal deposit from right to inter funds and a principal withdrawal of \$810.00 was made for cemetery repairs and maintenance; \$57,454.53 in principal was deposited to Lafayette Recreation from event income while \$46,951.78 in principal was withdrawn and \$3,500 in income was expended for Lafayette Rec event expenses; a principal withdrawal of \$3,284.10 was made from Town Buildings Vehicle fund for tires and rims for the 2023 one-ton truck and \$3,287.00 in principal was withdrawn from the Town Building Maintenance fund for a deposit for the Transfer Station hearing system.

<u>Minutes</u>: Draft minutes for the December 20, 2023 Trustees meeting were reviewed. Jan made a motion to approve the minutes as written with a second by Karen. The motion passed unanimously. Carol will send the final approved minutes for December's meeting to the Town Administrator and Secretary for posting to the Town's website.

### Other business:

Jan handed out the final Trustee of Trust Funds Transaction Log for 2023 along with a final Pending Disbursements sheet as of 12/27/2023.

The trustees voted for Jan to continue as Chairperson for 2024. The trustees completed a questionnaire provided by the Town's auditors that Jan will return to them.

There being no further business, the trustees adjourned the meeting at 5:20 pm. Due to a scheduling conflict, the next Trustee meeting will be on <u>Thursday, February 22, 2024</u> at Town Hall beginning at 4 pm.
